The Warren Township Supervisors met at the Municipal Building at 7 PM. All were present. Chairman Mark Wheaton opened the meeting with the flag salute being given.

There were no visitors present.

The secretary's minutes were read and approved. Mark made a motion to accept the minutes with suggested changes and Bill seconded.

OLD BUSINESS

Clean-Up Day was a huge success. The total cost for the day was as follows:

Mark gave a report on methods of posting speed limit signs on township roads. Unless roads are posted, the speed limit is 55 MPH.

NEW BUSINESS

Matt Dewing has requested the use of the building for a Community Outreach on Monday evenings beginning in August and running through December. The board approved the use of the building and there will be no charge since it is a community event. Mark made a motion and Fred seconded. Motion carried.

Melissa Smith also requested the use of the building one Friday night a month for her dance pupils to come together to utilize their skills. The building will be used for 2 hours. The supervisors approved this also. Bill made a motion and Mark seconded. Motion carried. She may use the building as long as it does not interfere with other events taking place that evening.

The letter was signed for the Fireman for the Parade for Firemen Field Days.

Fred recommended we have a Power Float valve put on the New International so materials will not be pushed off the road when plowing. Mark made a motion to have put on before winter at a cost of \$3555.75. Bill seconded. Motion carried.

Permits are not being issued at the present time for salt brine. Fred recommended purchasing a machine for \$12,000. That would enable us to make our own salt brine. This would cost \$0.14 a gallon to make. We will look into procedures and price using Liquid Calcium before proceeding with this purchase. Fred recommended that letters be send to Tina Picket and other representatives regarding Tom Wolf's recommendation that townships without their own police force be assessed \$25 per head for State Police protection. This would cost Warren Township \$24,375.00 per year
